

With the rollout of just over 2 million vaccines statewide, the reduction in cases, positivity rates, and hospitalizations, several CA counties, including Los Angeles, Orange, and San Bernardino Counties, have been moved to the Red Tier. Click <u>HERE</u> to see the latest information for your county.

The Red Tier allows for most businesses to operate indoors with modified capacity. There is also a 48-hour waiting period, and the announcement was made today, therefore operations can begin in the new tier on Monday. For a full list of operation guidelines, please **CLICK HERE**.

The State of California has modified the parameters and timeframe in which counties can move from tier to tier. The modified and less restrictive tier system also factors the number of vaccines administered in certain areas.
